
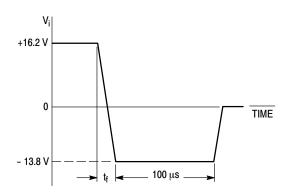


Figure 1. Input Waveform and Test Circuit for Determining Delay Time and Rise Time




Figure 2. Input Waveform and Test Circuit for Determining Storage Time and Fall Time




Figure 3. Collector Emitter Saturation Voltage vs. Collector Current




Figure 5. DC Current Gain vs. Collector Current

Figure 6. Saturation Region




Figure 7. Base–Emitter Turn–On Voltage vs.

Figure 8. Capacitance


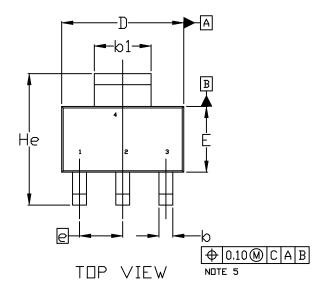


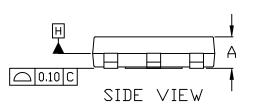
Figure 9. Safe Operating Area

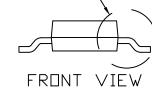
