

1. General description

Planar passivated sensitive gate four quadrant triac in a SOT428 (DPAK) surfacemountable plastic package intended for use in general purpose bidirectional switching and phase control applications. This sensitive gate "series E" triac is intended to be interfaced directly to microcontrollers, logic integrated circuits and other low power gate trigger circuits.



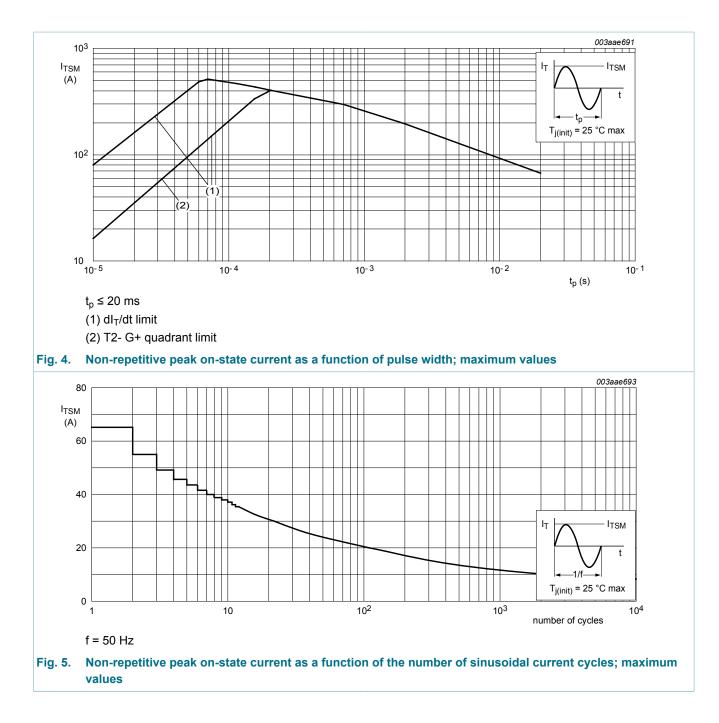




Fig. 6. Transient thermal impedance from junction to mounting base as a function of pulse width





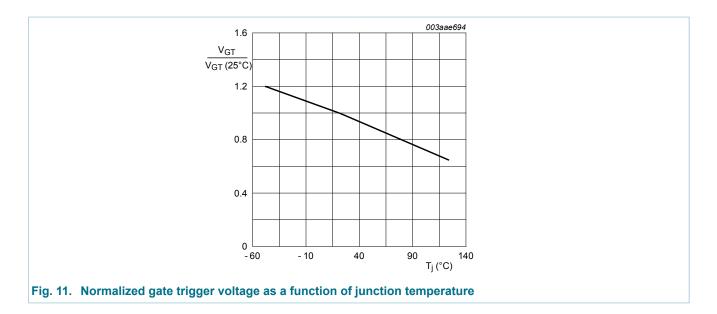

Fig. 10. On-state current as a function of on-state voltage


